# Public Hearing on Tentative Proposed Millage Rate and Budget

Wednesday, September 20<sup>th</sup>, 2017 at 5:01 p.m. 3941 SW 47<sup>th</sup> Avenue, Davie, FL

## Call to Order:

The Chair H. Collins Forman, Jr. called the Meeting of the Board of Supervisors of Tindall Hammock Irrigation and Soil Conservation District to order at 5:01 p.m. The meeting notice had been duly posted.

#### Roll Call:

The District Clerk called the roll. A quorum was present.

The Chair stated the name of the taxing District is Tindall Hammock Irrigation and Soil Conservation District.

The Chair presented the Proposed Millage Rate of 1.9000 Mills for Fiscal Year 2017/2018. The Chair stated the rolled-back rate is 1.6956 Mills.

The Chair presented the Tentative Budget for Fiscal Year 2017/2018 to the Board. The Chair asked for any questions or comments regarding the budget from the governing body. There were no questions or comments.

The Chair opened the hearing for public discussion.

Mrs. Mahaney reported that the amendment that was made to the Enterprise Fund Budget would affect line 31 of the budget exhibit by increasing the Fern Crest Utilities Enterprise Fund from \$3,780,150 to \$3,880,150. Mrs. Mahaney also reported that as a result the Reserves (Budgetary Fund Balance) would decrease from \$1,668,661 to \$1,568,661.

The Chair closed the public discussion portion of the hearing.

The Chair entertained a motion to tentatively adopt a tentative millage levy of 1.9000 Mills.

## Motion #1:

Dr. Walter Forman made a motion to adopt a tentative millage levy of 1.9000 Mills. Eric Forman seconded the motion. The motion carried.

The Chair entertained a motion to adopt the proposed tentative budget based on the tentative millage rate of 1,9000 Mills.

#### Motion #2:

Eric Forman made a motion to adopt the proposed tentative budget based on the tentative millage rate of 1.9000 mills. Dr. Walter Forman seconded the motion. The motion carried.

The Chair opened the hearing for discussion on the date, time and place for the final public hearing to determine the final millage rate and budget.

Mr. Bell reported that the meeting must be held between seven and fifteen days from today's date. Under those requirements, the Chair stated that the meeting must be held between September 27th and October 5th.

After discussion, the Chair announced that the date, time and place of the Final Budget Hearing will be Wednesday, October 4, 2017 at 5:01 p.m. at 3941 Southwest 47th Avenue, Davie, Florida 33314.

The Chair recognized and thanked Mr. Austin Forman for provided meeting space for the past several years.

There being no further business, the Chair closed the public hearing at 5:05 p.m.
