RESOLUTION OF THE TINDALL HAMMOCK IRRIGATION AND SOIL CONSERVATION DISTRICT APPROVING AND ADOPTING THE FINAL LEVYING OF AD VALOREM TAXES AND OPERATING MILLAGE RATE FOR TAXATION OF REAL PROPERTY LYING WITHIN THE BOUNDARIES OF TINDALL HAMMOCK IRRIGATION AND SOIL CONSERVATION DISTRICT FOR FISCAL YEAR 2024/2025 COMMENCING ON OCTOBER 1, 2024 AND ENDING ON SEPTEMBER 30, 2025; PROVIDING FOR SEVERABILITY AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, the Tindall Hammock Irrigation and Soil Conservation District is a political subdivision of the State of Florida, charged with the responsibility of controlling water and water tables with respect to lands within the area of its jurisdiction in Broward County, Florida and for operating and improving water systems, wastewater systems and reclaimed water systems within and without the District; and

WHEREAS, the Tindall Hammock Irrigation and Soil Conservation District located in Broward County, Florida, adopted Fiscal Year 2024/2025 Final Millage Rates following a public hearing as required by Florida Statutes Section 200.065; and

WHEREAS, the Tindall Hammock Irrigation and Soil Conservation District located in Broward County, Florida, held a public hearing as required by Florida Statutes Section 200.065; and

WHEREAS, the gross taxable value for operating purposes not exempt from taxation within Broward County has been certified by the Broward County Property Appraiser to the Tindall Hammock Irrigation and Soil Conservation District as \$1,170,270,560.

WHEREAS, a public hearing on the Tindall Hammock Irrigation and Soil Conservation District's final ad valorem taxes and operating millage rate for fiscal year 2024/2025 was held at 5:01 P.M. on Wednesday, the 25th day of September, 2024, by Communications Media Technology ("CMT") and in person at 3941 Southwest 47th Avenue, Davie, Florida.

NOW, THEREFORE, be it resolved by the Board of Supervisors of the Tindall Hammock Irrigation and Soil Conservation District in meeting assembled, that:

(1) The fiscal year 2024/2025 operating millage rate for Tindall Hammock Irrigation and Soil Conservation District is 1.3307 mills which is 7.38% greater than the rolled- back rate of 1.2393 mills.

(2) The final operating millage rate of 1.3307 mills for the general fund is for the calendar year 2024 to fund the expenses for the fiscal year commencing October 1, 2024 and ending September 30, 2025.

(3) This Resolution No. 2024-02 shall be and has been adopted prior to the adoption of Tindall Hammock Irrigation and Soil Conservation District's Resolution No. 2024-03 which will adopt the Tindall Hammock Irrigation and Soil Conservation District's final budget for fiscal year 2024/2025.

(4) The Secretary, Manager or Attorney of the Tindall Hammock Irrigation and Soil Conservation District is directed to forward certified copies of this Resolution to the Broward County Property Appraiser, Broward County Governmental Center, 115 South Andrews Avenue, Ft. Lauderdale, Florida 33301; the Broward County Revenue Collector, Broward County Governmental Center, 115 South Andrews Avenue, Ft. Lauderdale, Florida 33301, and the Florida Department of Revenue, Tallahassee, Florida 32301.

(5) If any one or more of the provisions of this Resolution shall be held contrary to any express provision of law or contrary to the policy of express law, though not expressly prohibited or against public policy, or shall for any reason whatsoever be held invalid, then such provision shall be null and void and shall be separate from the remaining provisions, and shall in no way affect the validity of all other provisions of this resolution.

NOW, THEREFORE, be it resolved by the Board of Supervisors of the Tindall Hammock Irrigation and Soil Conservation District in meeting assembled, that:

(1) The District's final budget for the fiscal year 2024/2025, a copy of which is attached hereto as Exhibit "A" is approved and adopted and shall become effective at the beginning of the 2024/2025 fiscal year, and the District's funds may be expended commencing October 1, 2024 and ending September 30, 2025.

(2) The proposed expenditures in the final budget are \$ 17,598,348. The budget is based upon the taxable value of real property for operating purposes of \$ 1,170,270,560.

(3) Funds of the District's 2024/2025 final budget not expended during the current fiscal year 2024/2025 may be used and expended during subsequent fiscal years.

(4) This Resolution No. 2024-03 shall be and has been adopted after the adoption of Tindall Hammock Irrigation and Soil Conservation District's Resolution No. 2024-02 which adopted the Tindall Hammock Irrigation and Soil Conservation District's final ad valorem taxes and operating millage rate for fiscal year 2024/2025.
